  - A. PC FSC 02- 9 – NS AQMD Chipping in lieu of burning –Jerry Hurley – **Nothing New to Report.**
  - B. PC FSC 04-1, 2, & 8 - C Road HFR – 117 acres – Jerry Hurley – **A supplemental request for additional funds to treat the remaining 40 acres has been submitted to the RAC.**
  - C. PC FSC 04-4 & 12 - Canyon Dam HFR - 900 acres– Jason Moghaddas – **The project has been put out for re-bid. Expect an award within the next month.**

- D. PC FSC 04-6 - County Stewardship Proposal – John Sheehan – **Nothing New to Report.**
  - E. PC FSC 05-2 & 6 - Whitehawk HFR- 121 acres – Jerry Hurley – **Timber harvesting is completed. Mastication is expected to be completed by 10/30/07.**
  - F. PC FSC 05-3 & 7 - Greenhorn HFR 30 acres – Jerry Hurley – **Due to higher than expected bids, a supplemental request for additional funds to treat the project has been submitted to the RAC.**
  - G. PC FSC 05-4 & 8 - Grizzly Ck. HFR- 128 acres – Jerry Hurley – **Contractor is assessing the project to complete surface fuel treatment in the units where harvesting has been completed.**

HFQLG –HFR project overview/relation to communities’ opportunities - Project mapping integration involving USFS, CDF and Fire Safe Council - PNF’s fuel reduction out year program of work – Jason Moghaddas – **Most of the Diamond project which was well along in the planning process was burned up in the moonlight fire. Prescribed burning will be occurring on the Meadow Valley Project this fall. The Empire project has survived the appeal process, but there are talks that a court injunction to stop it may be in the works.**

**NEW BUSINESS**

1. PC FSC’s Toll Free Number – Jerry Hurley – **Due to limited use and excessive costs for a couple calls, the 800 phone number for the Council has been dropped. Persons interested in contacting us by phone can still call 530-283-0829.**

**2. Biomass Chips to SPI Mill in Quincy – Brian West – Following a biomass chip fire at the SPI Quincy, they ceased purchasing biomass chips and removed their ramps. They allowed small trucks to bring in chips at no cost and no compensation. This has increased costs for PC FSC HFR projects, as chips now need to be hauled to Loyalton or Westwood, which has higher haul costs, or leaves the chips on the ground. Brian has worked with SPI in Quincy and they have agreed to purchase chips from PC FSC projects in the Quincy working circle. When these projects occur SPI requests that they be recognized in any press releases on those projects.**

**Website Self Paced Slide show – Jerry Hurley – A draft version of two slide shows was presented to Council member for comments. These self paced slide shows for :a) “Protecting Homes from Wildfire”, and b) “Protecting Homes & Communities from Wildfires”; are being developed to be put on our website to allow anyone to access useful wildfire mitigation information to enhance the public’s knowledge that with proper actions, homes & forests can survive the intrusion of wildfire.**
