## Updates

- Public Lands Projects Matt West:
  - Processing invoices
  - Things will ramp up as the snow starts melting for lakes Basin and Boyles Ravine, everything should be complete this Summer
- Private Lands Projects Katie Quinn & Rachel Wehrman:
  - Plumas Disadvantaged communities
    - 886 acres
  - Eastern Plumas Project
    - 5,000 acres total
    - Actively working landowner agreements for the commercial components of these projects
  - o EFoRT
    - Herbicide has been sprayed on projects and will continue to be monitored
  - o Mohawk
    - Currently working in Valley Ranch
    - About 85% is complete
    - Not operating currently because of weather
    - PCFSC will be finding a new operator to complete the work
    - PCFSC has replaced the forester who was previously on the project
  - Almanor Peninsula
    - Two parcels need archeological surveys
    - Getting in touch with Collins pine and Mason Bruce to come up with an agreement – we need to understand their THP since their projects run adjacent to ours
  - Hamilton Branch Clear Creek Vegetation Management
    - They just finished 146 acres of mastication, which means the whole project is nearly done.
    - All of the mastication and hand thin work is done people will be returning to the site to map things that still need work
  - Rachel and Katie applied for the wildfire prevention grant.
- County Coordination Liam Galleher:

- FSHV Insurance Calculations
  - The goal is to streamline access to insurance discounts based on location, Firewise status, and condition
- $\circ$  Applied for \$156,000 to fully fund the County Coordinator and Outreach Coordinator
- FRSC workshopping meeting weekly.
- Designing first meeting for FRSC goal is to meet in May before the field season gets too busy
- o Analyzing the FRSC Survey and the Wildfire Mitigation Census to structure meetings
- Senior Disabled Defensible Space Tommy Brenzovich:
  - Sign-ups are in full swing for the 2024 season
  - $\circ$   $\;$  Initial bid list will be consolidated by the end of the month
  - Chipping sign-ups are active for the 2024 season
  - The FEMA proposal for a Home Hardening Incentive program is still active, and matching funds have been secured
- Plumas Underburn Cooperative Logan Krahenbuhl:
  - Coordinating TREX with many partners
  - In February, PUC had a potluck / pile burning gathering
  - Attended outreach events to get community members interested in joining PUC
  - Burn ban is lifting in American Valley and Thompson Valley over the next couple of days, but be warned that the next couple of days are high-wind
  - PUC meeting tonight at the PCFSC offices
- Firewood Processing Facility Darrel Webster
  - CAL FIRE workforce development grant has been submitted 1.7 million ask.
  - We are currently looking at \$492,000 costs with an income of \$497,000.
  - Site development and review is currently being written up
  - On March 26<sup>th</sup>, the CEO of Airburner will be coming to Plumas County, and giving a run down of how their products will operate on PCFSC's landscape.
- Outreach Coordination Amber Hughes
  - Recipients of round-up at the register at the Feather River Food Co-Op's Portola location.
  - Received \$1,000 from the Common Good Foundation.
  - Delivered a presentation for Chester Firewise
  - Attended the FRC Job Fair
  - Wildfire Preparedness month is this May Wildfire Preparedness Fair is May 11<sup>th</sup>.
- 2. Standing Reports and Discussion
  - CAL FIRE: Alan Thornhill and Dustin Osborne provided an update.
    - Units are getting ready to get back into Fire Season in the middle of hiring new positions and training employees
      - Hired 4/6 positions
    - Concentrating on inspecting the communities that have never been inspected
  - Feather River College: Not present.
  - Feather River Resource Conservation District (RCD): Michael Hall provided an update.
    - Continuing work in Seneca with Joe Smailes and the Seneca Firewise community

- Field crews are fully staffed to do restoration monitoring
- o 5-person crew will be fully dedicated to hand-thinning
- Hired a new contracting forester, and full-time staff member
- Feather River Stewardship Coalition: Liam Galleher provided an update.
  - Meeting weekly with Zach Browning of Sierra institute to coordinate the revival of FRSC
  - First meeting should be sometime in May before field season gets too busy
- Firewise Communities:
  - o Valley Ranch
    - HFR in Mohawk/Valley ranch is 85% done, and community members are satisfied with the treatment.
    - 70% participation from landowners in the community
  - o Quincy
    - March 24<sup>th</sup> Quincy Firewise Meeting at West End Theater
  - o Whitehawk Ranch
    - HFR work is almost done in their area
    - Currently brainstorming for how to treat 200 acres on the old fish hatchery property
  - Meadow Valley
    - Engaged with multiple landowners to sign up for the HFR project hundreds of acres worth of treatment
- Industry Timber: Ann Anderson provided an update.
  - SPI continues to be interested in any high-impact projects put out by PCFSC.
- Industry Insurance: Mike Flanigan provided an update.
  - $\circ$  There will soon be a vote on HR 6861, which will substantially impact the insurance industry.
- Natural Resource Conservation Service (NRCS): Not present
- Northern Sierra AQMD: Julie Hunter and Mikki Brown provided an update.
  - On March 15th, the season restrictions will be lifted
  - The workshop reviewing rule 318 will be held at the Quincy library on this upcoming Monday
  - NSAQMD will host a Wood Stove workshop on May 18<sup>th</sup> at the veteran's hall from 12 4 PM
  - NSAQMD will be hosting a booth at the wildfire preparedness fair
- Plumas Corp: Scott Corey provided an update.
  - Mountain Meadows more re-vegetation is coming this year
  - o Implementation funds are on the way for projects in the Southern Sierra
  - Partner meeting on the 8<sup>th</sup> in the Sequoia area
  - Staff is curating a data portal to hold information from all active partners.
- Plumas County Office of Emergency Services (OES): Lori Pini provided an update.
  - Tracking damages that happened in the most recent storm Portola was hit hard with snow and power outages
  - 9 People in Portola reported damages, 1 in Quincy and 1 in La Porte
    - Most of these damages were fallen trees
- Plumas County Planning Department: No update.

  - Recently awarded 2 grants in Plumas County
    - Mule Deer Foundation

- University of California, Cooperative Extension: Not present.
- USFS Hazardous Fuels Reduction: Dave Kinateder provided an update.
  - The mass funds USDA received last year is currently going towards National Forest landscapes surrounding Graeagle.
  - Close to a decision on North Quincy.
  - Recovery Projects and Tributaries projects are still active
- Terra Fuego Bill Jacks provided an update.
  - Getting ready to burn in McLeod
- Plumas County Fire Chiefs Association Ron Heinbockel provided an update.
  - Ron Heinbockel is handing over his position to a new representative from the Fire Chiefs Association, but will still continue to stay on the PCFSC board.
- Sierra Institute Zach Browning provided an update.
  - Working with Liam Galleher to revive the Feather River Stewardship Coalition
  - Reach out to Zach Browning or Liam Galleher to get on the FRSC contact sheet.
- Mule Deer Foundation: No update.
